

This funding is available across three categories: **Emergency Fire Relief, General Emergency Assistance, and Spring 2025 Completion Grants.**

### **Emergency Fire Relief**

If you were affected by the wildfires, you may qualify for **direct relief funding**. We understand that the impact of these events goes beyond physical loss and can disrupt all aspects of daily life.

You may be eligible for assistance if you meet any of the following:

- **Loss or Damage to Residence:** Your primary residence (home, apartment, room) was damaged or destroyed due to the fires. This includes smoke damage, structural damage, or being rendered uninhabitable.
- **Evacuation or Displacement:** You were required to evacuate your home, even temporarily, due to fire danger or road closures. This includes those who stayed with family/friends, in hotels, shelters, or other temporary housing.
- **Loss of Income or Employment:** You lost your job, had reduced hours, or missed work (including gig, part-time, or informal employment) because of the fires. For example, your workplace may have closed, or you would be unable to commute due to road conditions.
- **Increased Expenses Due to the Fires:** You incurred **unexpected costs** such as: Food and essentials during evacuation, replacement of destroyed or damaged clothing, textbooks, or school supplies

### **General Emergency Assistance**

We also offer help to anyone in our campus community experiencing **unexpected financial hardship** unrelated to the fires. This could include:

- Medical emergencies
- Transportation issues
- Unexpected bills or loss of support

These funds are designed to provide short-term relief and help you stay focused on school and will come in the form of a one-time payment via check.

### **Spring 2025 Completion Grant**

If you're **on track to graduate in June 2025** and need help finishing your Spring 2025 classes, the **Completion Grant** may be right for you.

#### **Eligibility Criteria:**

- Minimum **2.0 GPA**
- No more than **75 completed units** (except for Nursing and Rad-Tech students)
- Provide **Spring 2025 course enrollment**
- Submit an **unofficial transcript**
- Provide a **Financial Need screen** showing unmet need (via Financial Aid portal)
- Write a **500-word (half-page) statement** explaining your need for assistance

The grant can help cover tuition, fees, books, supplies, or pay off small balances that prevent registration.
